The objects of this company comprise 27 items, as follows:

- (1) To carry on the business of producing all kinds of chemical products (both organic and inorganic), including
 - a) Chemical power and/or Poly Vinyl Chloride (PVC) powder and pellets, with or without mixtures of other chemical products
 - b) Vinyl Chloride Monomer (VCM), chlorine, caustic soda
 - c) Ethylene Dichloride (EDC)
 - d) Sodium Hypochlorite
 - e) Hydrogen
 - f) Hydrochloric Acid
 - g) NaOH - Micropearls and NaOH - Flake

- (2) To carry on the business of trading in all kinds of chemical products; to carry on the business of importing and exporting all kinds of chemical products, including organic and inorganic chemical products, including but not limited to fluorine derivatives, chlorine derivatives, and Polypropylene Glycol.
- (3) To import or locally source, lease, buy on hire-purchase or otherwise acquire raw materials, supplies, equipment, devices, appliances and machines used for manufacturing and in laboratories, including for retail and wholesale, in accordance with the Company's objectives.
